#### Terms & Conditions 條款及細則:

- 1. "Monthly Stocks Plan" is only available to the securities cash account of Ever-Long Securities Company Limited ("Ever-Long Securities").
  - 「月供股票計劃」只適用於長雄證券有限公司("長雄證券")的現金交易帳戶。
- 2. The Client(s) can choose 1 or 2 listed stock(s) for minimum monthly contribution HK\$5,000 and 2 or 4 listed stock(s) for minimum monthly contribution HK\$10,000 in the "Monthly Stocks Plan". The contribution cycle should not be less than 12 months.
  - 客戶申請「月供股票計劃」時,每月最低供款金額港幣五千元可選擇 1 或 2 隻股票,而每月最低供款金額港幣一萬元則可選擇 2 或 4 隻股票。客戶供款期最少為 12 個月。
- 3. The Client can choose the stock(s) from the list of "Designated Stocks of Monthly Stock Plan" or other listed stock(s) after consulting with Ever-Long Securities.

- 4. Monthly Contribution 每月供款:
  - A. The Client(s) should pay the monthly contribution amounts prescribed by Ever-Long Securities. The "Payment Date" is 1:00 PM of the 5th day of each month. Payment should be deposited to our designated bank account of Ever-Long Securities for the contribution before Payment Date (if the day is a non-trading day, it will be postponed to next trading day for the contribution). The Client(s) should deposit the bank cheque before three settlement days in advance (if using the bank cheque). Otherwise interest and administrative fee will be charged on the Client for late payment and such interest and administrative fee will be directly made to the account of the Client.

  - C. The deadline for all delayed "Payment Day" is the 15th day of each month. For any reason (such as suspensions of company announced by HKEX) that no deposits can be made before 15th day of a month, the "Payment Date" of that month will be cancelled.

#### 5. Buying or Selling 買入或沽出:

A. The Client(s) is required to complete the Application Form – "Monthly Stocks Plan" and contribute at least HK\$5,000 for the first monthly contribution. Your account executive will buy the listed stocks in the trading days of following week after your monthly contribution.

客戶需填妥「月供股票計劃」申請表並預留欲買入股票金額(最少港幣五仟元)。閣下的客戶主任會在「月供日」後一個星期內的交易日買入相關股票。

- B. The Client(s) can sell all the stocks through the phone at the time determined by him. 客戶可隨時透過指定落盤電話以市價沽出全數股票。
- C. The Client(s) should pay the handling fees for the buying or selling including the brokerage commission (Minimum HK\$50), government stamp duty, transaction levy and exchange fees. 客戶須繳付買入或沽出一般手續費:包括經紀佣金(最低港幣 50 元)、政府印花稅、交易徵費及交易所費用。
- D. The Client(s) will be charged for the remaining brokerage commission in the minimum period of 12 months if he/ they terminate(s) or exit(s) the Monthly Stocks Plan before the expiry of the minimum contribution period of 12 months.
