- 1. to pay/transfer any sum of the Monies to any overseas broker(s) and/or overseas clearing firm(s) and their successors and assigns for the purpose of trading or meeting the settlement or margin requirement (if applicable) of my/our overseas securities and/or futures contracts transactions; and/or 將任何數額之款項支付予任何海外經紀商及/或海外結算公司及其繼承人及受讓人,以作為本人/吾等買賣海外證券及/或期貨合約之用,或履行交收或保證金的要求(如適用);及/或
- 2. transfer any sum of Monies interchangeably between any of the segregated accounts maintained at any time by ELS and/or ELF, for the purpose of trading or meeting the settlement or margin requirement (if applicable) of my/our local and/or overseas securities and/or futures contracts transactions.
